Randall Auxier – is a Professor of Philosophy at Southern Illinois University, where he specializes in the philosophy of culture, process philosophy, and personalism. He is the author of *Time, Will, and Purpose* (2013), and co-author of *The Quantum of Explanation* (forthcoming 2015). He has edited or co-edited many books, including eight volumes of the Library of Living Philosophers, including most recently *The Philosophy of Arthur Danto* (2013) and *The Philosophy of Hilary Putnam* (2015, forthcoming). He is an author of many scholarly articles and popular writings in philosophy. He maintains a blog with a collection of writers under the name Radically Empirical (http://radicallyempirical.com/) and also writes for two weekly newspapers.

Noël Carroll – is a Distinguished Professor in the Philosophy Program of the Graduate Center of the City University of New York. A past president of the American Society for Aesthetics. His recent books include On Criticism (2008), Art in Three Dimensions (2012), Living in an Artworld (2012), Minerva's Night Out: Philosophy, Movies and Popular Culture (2013) and Humour: A Very Short Introduction (2014).

Jakub Chachulski – doktor sztuki (Uniwersytet Muzyczny Fryderyka Chopina w Warszawie, 2015), autor książki Między poprawnością historyczną a interpretacją. Fortepianowe wykonania utworów J. S. Bacha a założenia Historically Informed Performance – studium wybranych nagrań Wolfganga Rübsama, Lublin, Polihymnia 2012, a także publikacji z dziedziny teorii i filozofii muzyki.

Stephen Davies – teaches philosophy at the University of Auckland, New Zealand. He is a Vice-President of the International Association for Aesthetics and a former President of the American Society for Aesthetics. His most recent book is *The Artful Species: Aesthetics, Art, and Evolution* (2013).

Cynthia Freeland – is a Moores Distinguish Professor of Philosophy at the University of Houston. She is the author of *But Is It Art?* (2001) and *Portraits and Persons* (2010), as well as articles on topics in feminist theory and ancient philosophy. Her most recent publication is a special issue of "The Journal of Aesthetics and Art Criticism" co-edited with Christy Mag Uidhir on Printmaking and the Philosophy of Art (Winter 2015).

Mirosław Jasiński – is an art historian, Polish philologist (University of Wrocław, art critic, screenwriter, producer of documentaries, diplomat. Since 2012 he is the director of The City Gallery in Wrocław. In 1991-1992 M. Jasiński was a provincial governor (Wroclaw Voivodeship), in 2001-2006 he was the director of the Polish Institute in Prague. He is the author of ca. 100 films and documentaries, co-author (together with Mirosław Spychalski) of the book *Opowieść heroiczna*, 1988 (*Heroic Story*). The creator and head (since 1982) of the Polish-Czech-Slovak Solidarity – the organization of Polish, Czech and Slovak dissidents, member of the Polish-Czech Forum and the Council of Polish-Czech-Slovak Solidarity Foundation.

Gemma Argüello Manresa – is a Visiting Scholar at Universidad Autónoma-Lerma (UAM-Lerma). She was awarded her PhD (Cum Laude) from the Universitat Autònoma de Barcelona. Her dissertation *Sympathy for the Devil. The Paradox of Emotional Response to Fiction* was published in 2010. She had previously obtained two Master Degrees in Aesthetics and Art Theory by the same University. Recently she has participated in the research projects "Art and Community" and "Creativity and Imagination in the Arts" at UAM-Lerma, and "Aesthetics and Naturalism" at the Institute of Philosophical Research at Universidad Nacional Autónoma de México where she was Postdoctoral Fellow. This year she co-edited the book *Comunidades Alternas en el Arte. Espacio, Memoria y Archivo* en el Arte Relacional (Alternative Communities in Art. Space, Memory and Archive in Relational Art) (2014). She works on aesthetics and cognitive science; philosophy of digital art; philosophy of art, politics and ethics; and philosophy of film.

Kalle Puolakka – received his doctorate from the University of Helsinki in 2009 and currently works as a university researcher at the International Institute of Applied Aesthetics. He was granted the title of Adjunct Professor (docent) of aesthetics (University of Helsinki) in 2012 and in the fall term 2013, he was a visiting fellow at the Swedish Collegium for Advanced Study (Uppsala). Puolakka is the author of *Relativism and Intentionalism in Interpretation: Davidson, Hermeneutics, and Pragmatism* (2011). His recent publications include "Pragmatist Cultural Naturalism: Dewey and Rorty" (*The European Legacy: Toward New Paradigms*), "Dewey and Everyday Aesthetics – A New Look" (*Contemporary Aesthetics*).

Elisabeth Schellekens – is a Chair Professor of Aesthetics in the Philosophy Department at Uppsala University and a Senior Research Fellow at the University of Durham. She is an Editor (with John Hyman) of the *British Journal of Aesthetics*. Her main research interests include aesthetic normativity, the objectivity/subjectivity and realism/anti-realism distinctions, the relations between art, knowledge and morality, the possibility of non-perceptual aesthetic value and empirical aesthetics.

Ian Verstegen – studied art history and experimental psychology, receiving his PhD with Marcia Hall at Temple University with a dissertation on the color and painting technique of Federico Barocci. Recent publications include *A Realist Theory of Art History* (2014) and *Cognitive Iconology: How and When Psychology Explains Images* and *A Realist Theory of Art History* (2014). He is associate director of Visual Studies at the University of Pennsylvania.

Joanna Winnicka-Gburek – earned her MA in painting from the University of Silesia and received her PhD in theory of art from the University of Wrocław. During the 80s and 90s she took part in numerous painting exhibitions and was awarded on several occasions. Since 1996 she has been working at the University of Silesia at the Department of Ethnology and Educational Science. She specializes in theory and history of art, and art criticism defined as a kind of culture education. She cooperates with the journal *Estetyka i krytyka (Aesthetics and Criticism)* issued by the Institute of Philosophy at the Jagiellonian University. Now she is preparing a book about personalist art criticism as a form of ethical criticism of art.
