P. Yale Inv. 1624 is a receipt issued on January 25 A.D. 203 for partial repayment of two loans. Both of the loans bore interest at the usual rate of twelve per cent per annum. Three quarters of the first loan and one half of the second loan were assigned to a third person by virtue of an arrangement contracted, with the consent of the debtors, between the third person and the creditor. The former claims the collection of the assigned sums. The receipt in agreement with a common practice for partial receipts, is drawn up in the private chirographic form.

H. G. GUNDEL, Kleine Beiträge zum römischen Heerwesen in Aegypten.
P. Giss. Bibl. inv. 282 und 27. Giessen 1940.

The first papyrus of the 3rd cent. A.D. is of administrative character and deals with the distribution of barley to the cavalrymen of the Roman army; the second of 222-235 A.D. is a report to a centurio.

E. BAYER, Urkunden aus Soknopaiu Nesos. Aegyptus XX (1940), p. 299ff.

There are six documents published in this collection. N° 1 (105 A.D.) is an application for lease, N° 2 (143 A.D.) an  $\dot{\alpha}\pi\sigma\gamma\rho\alpha\dot{\gamma}\eta$   $\kappa\alpha\mu\dot{\eta}\lambda\omega\nu$ , N° 3 (154/155 A.D.), and 5 (205 A.D.) receipts on taxes, N° 4 (180 A.D.) an application to the strategos by the applicant on his behalf and on behalf of his brothers of age, and of his sister under age, in an hereditary affair (hereditatis petitio).

O. MONTEVECCHI, Dai papiri inediti della raccolta Milanese. Aegyptus, XX (1940), p. 39-42.

This is a continuation of the papyri published in Aegyptus XV (1935), p. 239-254. N° 5 (108 A.D.) is a notification of death of an  $d\phi \eta \lambda l \xi$  with the usual formula:  $\tau a \gamma \eta \nu a l$  arith  $\nu \tau \sigma i s$   $\tau \epsilon \tau \epsilon \lambda \epsilon \upsilon \tau \eta (\kappa \delta \sigma l)$ .

H. C. YOUTIE, New readings in Michigan Ostraca. Trans. Am. Phil. Ass. LXXII (1941), p. 439.

The author publishes 1. a receipt for work on the embankments, 2. a receipt for three days on the embankments, 3. a receipt for the delivery of chaff, 4. another receipt for the delivery of chaff, 5. a list of liturgical workers, 6. a school exercise.
