J. F. Gilliam, *A Roman naval Roster: P. Ryland's 79* (repr. from *Classical Philology*, vol. XCVIII, nr 2, April 1953).

Gilliam shows that it is a part of a roster of men from at least two ships. Lines 1—9 conclude the list of those from one; further lines — those from the *liburna* "Mercury". It appears that the document does not contain a complete roster of shipping companies but only specifies certain groups of men selected for some unknown reason. At any rate there is nothing to suggest that these lines form a part of a *pridianum*.

LEGAL PERSONS

R. Taubenschlag, *Die Prozesse der juristischen Personen im Rechte der Papyri* (Studia et documenta historiae et iuris XVIII, 115—125).

In this study the author discusses the law-suits in which legal persons (the fisc, the municipia and municipal senates) are represented by respective deputies. These lawsuits were decided either in the way of extraordinary proceedings or in the way of normal fiscal procedure.

Slavery

A. P. Kazdan, *O niekotorych voprosach istorii stanovlenija feodalnykh atnošenij v Rimskoj Imperii* (Vestnik Drevnej Istorii Nr 3 (1953) p. 77—106).

This article deals with the question of process and forms concerning the transition from the s.c. slavery system to the feudal system. It has in fact been written to supplement an article by E. M. Štajerman under the title: *Problema padienija rabovladiel-českogo stroja* (Vestnik Drevnej Istorii No. 2 (1953) p. 51—79) concerning the same subject. The article deserves attention of the papyrologists because it makes use to a large extent of papyrological material. His remarks on the slavery papyri of the VI cent. are also noteworthy.

THE LAW OF PROPERTY

R. Taubenschlag, *Miscellanea papirologica* (Aegyptus XXXII, p. 459—465).

This article is devoted to the $\delta\acute{\iota}\kappa\eta\ \kappa\alpha\rho\tau\omicron\upsilon$ and to the question in what manner the Greco-Egyptian law protects the proprietor of the ground against someone who intends to build or who has already built on that ground. The problem in what manner this law protects the proprietor who intends to build on his ground and is impeded by someone, is also discussed.
