E. Seidl, *Die Jurisprudenz der Statthalter Aegyptens in der Prinzipatszeit* (estr. da *Studi in on. di U.E. Paoli*, Firenze 1955).

In this study the author deals with the question which were the methods adopted by the judges of Egypt when passing their sentences. He reviews the texts in their chronological order after the governors in whose names the preserved verdicts were passed. He also reminds that the verdicts were always issued by a *consilium* so that the authorship of a verdict could as well be ascribed to the governor himself as to an anonymous jurist belonging to his attendance.

E. Seidl, *Zum juristischen Wortschatz der alten Aegypter* (*Festschr. F. Dornseiff* [1953] 320—329).

In Ermann-Grapow, *The Egyptian Language* is given a lexicon and its vol. IV contains a collection of words following their meaning and practice. One column deals with "law", the other with "earning, propriety and loss".

The author reviews several legal terms such as: agency, administrator, guardian, ownership and possession, purchase, expressions for gratuitous deeds, corn-loan, lease, mandate, fulfillment of a contract, annulation of a contract, several terms from the sphere of the law of inheritance, the law of matrimony and the penal law.

D. Cohen, *Schets van het notariaat in het oude Egypte* (*Ars notariatus V*) (Amsterdam 1955).

The book is divided into five parts: I. treats of the history of Egypt, II. of acts, III. of the office of a notary and the notarial acts, IV. of keeping and registration of the acts. The final part V gives examples of acts.

R. Calderini, *De interpretibus quaedam in papyris* (*Aegyptus XXXIII* (2) [1953] p. 341 ff.).

In this article the author gives a list of interpreters which we meet in the papyri and stresses that they were employed for the translation of documents from Egyptian into Greek as well as from Latin into Greek. This article is closely linked with my article *The interpreters in the papyri* (*Charisteria Sinko* [1951] 361 ff.).

Alvaro d'Ors, *Epigrafia juridica griega y romana* (IV) (1950—1953) (exc. ex *SDHI* XX [1954] 403—484).

This work comprises three parts: Part I — Generalia, Part II — "Noticias regionales" and Part III — "Noticias temáticas". Under II § 17 the author (p. 425) refers to Egypt and p. 442 — particularly to the legislative activity of the Lagides.
