Vandoni edits a very interesting document which concerns divorce. As in other documents of this kind (cf. Erdman, *Sav. Zeitschr.* 61 (1944) 44 ff.; Flore, *Studi in onore di P. de Francisci* 1 (1956) 395 ff.) the form reads: ὁμολογοῦσιν... .. συνῆρσθαι τῆν πρὸς ἀλλήλων συμβίωσιν, ἥτις αὐτοῖς συνεστήκεν ἀπὸ συγγραφῆς ὁμολογίας γαμοῦ κ.τ.λ. Further on there follow the clauses concerning: the restitution of φερνή and παράφερνη and the mutual obligation not to bring any action which could be grounded on the fact of the foregoing cohabitation, or on the consequence of this fact. Curious is the clause according to which the divorced woman is permitted σὺν ἑτέρῳ ἀνδρὶ συνβιοῦν ἀσοικοφαντήτω. The same editor publishes the following two documents: Pap. Mil. No. inv. 57 148/49 A.D.; they are receipts for some payment in corn. C. M. Burri edits the receipts given by *sitologi* (Pap. Mil. No. inv. 154 127 A.D.). Pap. Mil. No. inv. 105 (166—167 A.D.) and 242 (III cent. A.D.) published by C. R. Carrara contain accounts. The P. Mil. No. inv. 146 (II—III cent. A.D.) edited by D. Manfredi is a private letter. [H.K.]

Ladislav Varel, *Aus den Archiven von Theadelphia. Papyri Wessely Pragenses (Listy Filologické vol. VI (1958) 2 pp. 69—77; vol. VII (1959) 1 pp. 3—18; 2 pp. 81—86).*

The editor publishes 23 further papyri from the archives from Theadelphia. Nos 9 (250—255) and 16 (undated) contain the fragments of some λόγος ἀργυρικός. No. 10 recto (252—253 A.D.) gives seven columns of accounts concerning the economic activity of a certain Heroneinos as a φροντιστής. Nos 11 and 12 (251/52 A.D.) are the fragments of some λόγος γενικός of Heroneinos. No 12 (undated) is a receipt for the performed work. No 17 (verso of the No. 10) contains a long account (148 vv.) of hay given as fodder to the cattle in time of various field works λόγος ἀπεργασίας. No. 18 is a fragment of λόγου χόρτου. No. 19 verso gives two columns of an accounts of crops obtained in the month Epeiph — Mesore and in the month Mecheir of the following year. This account originates from Theadelphia or its neighbourhood. No 21 (251—252) contains an account of the wine delivered from the property of Pontikos, friend of Heroneinos.

William H. P. Hath — C. Bradford Wells, *A hitherto unpublished Fragment of the Epistle to the Ephesians* (*The Harvard Theolog. Rev.* vol. 51 (1958) No. 1 pp. 33—35).

This unpublished fragment of the epistle to the Ephesians designated in Gorgys list of the New Testament fragments as P. 49, contains 25 lines on the recto as well as on the verso. The editors place the date of this fragment of unknown provenience in the first half of the second century. [H.K.]

John N. Hough, *A Dike Tax Receipt. P. Colorado 1* (*Chronique d'Égypte* t. 34 No. 68 (1959) pp. 289—291).

The editor publishes P. Colorado 1 which is a receipt for the *χωματικόν*. This document comes from Socnopaei Nesus in Fayum and is dated August 23, 166 A.D. The edition is provided with a photograph of the document, a commentary and an English translation. [C.K.]

J. F. Gilliam, *Two Latin Letters from Dura-Europos of A.D. 221* (*Études de Papyrologie*, t. 8 (1957) pp. 49—58, pl. 4).

The texts of P. Dura 15a and 15b (cf. *The Excavations of Dura-Europos. Final Report V. Part I. Nos 64a and 64b*) come from the archives of the *cohors XX Palmyrenorum*. P. Dura 15a is a letter of the *praepositus* Aurelius Rufinus to the cohort tribune Iustillus concerning the delivery of barley from the imperial domain to cavalrymen or muleteers who were in the detachment at Apadana. P. Dura 15b — also a letter of Aurelius Rufinus to Iustillus — concerns the giving satisfaction of an indefinite kind by Sozon, clerk in the *legio XVI Flavia firma Antoniniana* probably to Hanina Bellaeus, soldier of the Palmyrene cohort.
