- Janina Abramowska** – literary historian, Professor of the A. Mickiewicz University in Poznań; major works: “O szesnastowiecznych koncepcjach tragizmu” (On 16th-Century Conceptions of the Tragic), [in:] *Estetyka, poetyka, literatura*, Wrocław 1973; *Ład i fortuna. O tragedii renesansowej w Polsce (Order and Fortune. On Polish Renaissance Tragedy)*, Wrocław 1974.
- Hanna Dziechcińska** – historian of Renaissance and Baroque literature, concerned mainly with problems of literary culture, Professor of the Institute of Literary Studies of the Polish Academy of Sciences; major works: *Biografistyka staropolska w latach 1473–1627. Kierunki i odmiany (Polish Biographical Writings 1473–1627. Directions and Varieties)*, Wrocław 1971; *W krzywym zwierciadle. O karykaturze i pamflecie czasów renesansu (In the Distorting Mirror. On Renaissance Caricature and Pamphlet)*, Wrocław 1976; *Literatura a zabawa (Literature and Play)*, Warszawa 1981.
- Michał Głowiński** (b. 1934) – literary historian and theoretician, Professor of the Institute of Literary Studies of the Polish Academy of Sciences, concerned mainly with relation of poetics and literary sociology, and particularly with problems of reception of literature; major works published in the last decade: *Gry powieściowe. Szkice z teorii i historii form narracyjnych (The Novel Games. Studies in the Theory and History of Narrative Forms)*, Warszawa 1973; *Style odbioru (Styles of Literary Reception)*, Warszawa 1977; *Zaświat przedstawiony (The Other World Presented)*, Warszawa 1981.
- Roman Ingarden** (1893–1970) – philosopher, aesthetician and theoretician of literature, disciple of Husserl, one of the leading representatives of the phenomenological thought. He gained recognition throughout the world, his works being translated into many languages, and found many followers creating a philosophical school—in Lvov (before 1939) and in Cracow (after 1945).

- Mieczysław Klimowicz** (b. 1919) – literary historian, Professor of the Wrocław University, particularly concerned with comparative studies, authors of many works on the theatre of the Enlightenment period and of a university handbook on the Polish literature of the Enlightenment.
- Grzegorz Sinko** (b. 1923) – historian of English literature, especially concerned with semiotics of the theatre, author of many studies in history and theory of drama. Professor of the Art Institute of the Polish Academy of Sciences; recent works: *Kryzys języka w dramacie współczesnym. Rzeczywistość czy złudzenie?* (*Language in Modern Drama at the Crisis. Reality or Delusion?*), Wrocław 1977; *Opis przedstawienia teatralnego – problem semiotyczny* (*Descriptions of a Theatrical Performance – a Semiotic Problem*), Wrocław 1982.
- Lech Sokół** (b. 1942) – of the Art Institute of the Polish Academy of Sciences, dealing mainly with the theatre of the turn of the century, editor of Strindberg and S.I. Witkiewicz, author of studies devoted to those two playwrights, e.g. *Groteska w teatrze S. I. Witkiewicza* (*Grotesque in S.I. Witkiewicz's Theatre*), now working on a comparative study of Strindberg and S. I. Witkiewicz.
